Labour Market Information from the Department of Advanced Education Skills and Training

According to the Labour Market Outlook 2020 ...

- The average number of weeks worked per year in Newfoundland and Labrador has been increasing however; the average length of time people remain unemployed during the year has been decreasing and is now lower than the Canadian average.
- It is anticipated that approximately 66.7% of all job openings in the 2011 to 2020 period will be in management occupations or will require some form of post-secondary education.
- Job openings that arise due to retirements and deaths will account for a significant number of job openings over the next ten years. Over 70,000 job openings are anticipated to arise between 2011 and 2020, with attrition accounting for up to 89% of these openings. Attrition will account for approximately 57% of all job openings in the 2011 to 2015 period, and all net job openings in the latter part of the forecast period.

Activity within our Area

Congratulations to the Town of Appleton on being the first in the Province to secure funding for the purchase of high density polyethylene surface that can be used year-round and comes complete with standard rink boards, glass, safety netting and regulation hockey nets, This project is cost share on a 90/10 split between the Dept. of Municipal Affairs and the Town of Appleton.

Tides Canada, the country's largest public foundation to the environment and social justice, placed the Shorefast Foundation in its Top 10 list for funding social enterprise in geo tourism, the arts and sustainable fisheries on Fogo and Change Islands. Shorefast were chosen for believing there is a future for rural communities in Canada and that future is built on innovation, resilience, optimism and the ability to adapt.

The Glovertown Marina is nestled in the northwest corner of Alexander Bay around the shores of Glovertown. Phase 1 of the development has been completed and some boats are now winterized on site. Services include a sheltered harbour protected by a breakwater, floating docks, lift out and launch facilities, storage areas, electrical services, plus repair and maintenance advice. Services planned for next year include: water and sewer, Laundromat, washrooms and showers and internet.

The Gander International Airport Authority expects 2011 to be a good year for business. As of the end of November, the airport had enjoyed a 20 per cent year to date increase in passenger traffic and is expecting to post a 10-year high for domestic traffic at Gander. The airport authority attributes this to incremental seat capacity available through Air Canada's seasonal service to Toronto and continued strong demand for service to Labrador. The airport also reported a high for passenger movements to the Caribbean through Sunwing's winter service to the Dominican Republic and Cuba. "We are really encouraged with the direction our passenger traffic is headed ," said GIAA President and CEO Gary Vey. "It's really a testament to the strength of the Central Newfoundland economy and we are in a good position to introduce new frequency and capacity to provide the timely, affordable air travel options our market demands.

The Chamber was honored and proud to participate with other delegates from Gander who were in Washington, D.C. to receive the "International Community Resilience Award" as part of "The 9/11 Tenth Anniversary Summit: Remembrance, Renewal, Resilience" event. Chamber Executive Director, Hazel Bishop, along with Premier Dunderdale, Mayor Elliott, Jake Turner, Beulah Cooper, Pastor Ralph Benson, Des Dillon, and Major Wade Budgell attended the ceremony. The delegation also met with Congresswoman Louise Slaughter who presented the Town of Gander and the Province with a framed copy of the Resolution she brought forward in the House of Representatives to "Recognize and thank the residents of Gander, NL and all other citizens across Canada who came to the aid of the United states citizens during an unprecedented crisis, challenge and uncertainty". A special thank-you to the Canadian Embassy and TD Canada Trust for making this trip possible. Also congratulations to Destination Gander on the superb job with the 9/11 service and all of the events held during the month of September to raise funds for the Families of Freedom Scholarship Fund.
